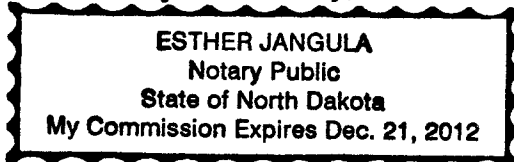

ORDER CHANGING BUSINESS HOURS


