1. Any person having a claim against VeraSun Hankinson, LLC for the non-payment of grain purchased or stored by VeraSun Hankinson, LLC at its warehouse facility in Hankinson, North Dakota, shall file the claim with the Public Service Commission, 600 East Boulevard Avenue, Department 408, Bismarck, North Dakota 58505-0480.

2. Claims must be filed within forty-five (45) days after the last publication of this notice.
3. Persons filing claims with the Public Service Commission shall include receipts or sufficient documentation to enable the Commission to determine the validity of the claims. This could include unsatisfied scale tickets, warehouse receipts, dishonored checks, and any related contracts.
4. Unless a claim is filed with the Public Service Commission within the time specified, the claimant may be barred from participation in the trust fund.
