- It is the purpose of the Ordinance to promote public health, safety and welfare; and to minimize public and private losses due to flood conditions in specific areas by provisions designed to:
- protect human life and health;
 - minimize expenditure of public funds for costly flood control projects;
 - minimize the need for rescue and relief efforts associated with flooding generally undertaken at the expense of the general public;
 - minimize prolonged business interruptions;
 - minimize damage to public facilities and utilities such as water and gas mains, electric, phone and sewer lines, streets and bridges;
 - maintain a stable tax base by providing for the second use and development of special flood hazard areas so as to minimize future flood blight areas;
 - ensure that potential buyers are notified that property is in a special flood hazard area;
 - to ensure that those who occupy the special flood hazard areas assume responsibility for their actions.
