SUPPLEMENTAL AFFIDAVIT

James Wirtz states under oath as follows:

1. I swear and affirm, upon penalty of perjury, that the statements made in this affidavit are true and correct.
2. On September 11, 2008, I signed Cash Contract Number VHN1000532, agreeing to sell 4,000 bushels of corn, priced at \$5.19 per bushel for delivery to the ethanol facility in Hankinson, North Dakota, during the month of September 2008. The payment terms as agreed in the contract were "Net 10" as provided in Exhibit TJW-1 attached to the Affidavit of Timothy Erdmann in Support of Nonpayment of Grain Claim of James Wirtz executed on March 10, 2010 and attached to this Affidavit.

3. Following delivery of the corn on this contract, I received US Bio Hankinson, LLC check number 6841 dated September 22, 2008, for the amount of \$26,934.70. The check was issued to me and Bank of the West. I usually cash checks right away, but I was busy working long hours and misplaced the check. Approximately three or four weeks after I first received the check I called Jon Anderson, Grain Procurement Manger at the Hankinson ethanol facility, to tell him that I couldn't find the check and asked for a new check to be issued. He didn't really have anything to say and I did not receive a new check.
4. I finally found the check in December of 2008 and I deposited it with Bank of the West. I received a statement from Bank of the West dated December 9, 2008, along with a copy of the check marked RETURN REASON – C, STOP PAYMENT, Do Not Re-deposit. When I first deposited the check, I thought the check would be good because the banker told me that earlier checks had been returned, but then when they were re-deposited a second time, they were good.
5. I called Jon Anderson again after the check was returned. He told me that VeraSun had filed for bankruptcy and the check could not be cashed. Jon gave me a Sioux Falls number and when I called Sioux Falls, I was told they were in bankruptcy.
6. I am not familiar with credit-sale contracts because I always sell my grain for cash. I never intended to extend credit to VeraSun Hankinson, LLC for the sale of my corn and I did not execute any oral or written agreement to sell my corn under a credit-sale arrangement.

7. I did not file a claim in the bankruptcy court.
