

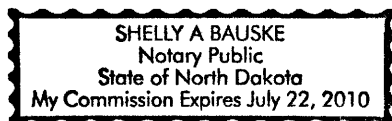

NOTICE OF RECEIPT OF RENEWAL AND REVISION APPLICATIONS

April 22, 2009

The Falkirk Mining Company has applied to renew Surface Coal Mining Permit NAFK-8705 and to update legal, financial, and ownership information and operations and reclamation plans to continue surface coal mining and reclamation operations in the existing permit area located in:

All or portions of Sections 3, 4, 5, 6, 8, and 9, T145N, R82W; Sections 19, 20, 27, 28, 29, 30, 31, 32, 33, and 34, T146N, R82W; Section 1, T145N, R83W; and, Sections 22, 23, 24, 25, 26, 27, 35, and 36, T146N, R83W, all in McLean County, containing 10,880.9 acres.

The five-year permit renewal will allow Falkirk to continue mining and reclamation operations in Permit No. NAFK-8705 until July 6, 2014. Revision No. 32 updates the mining and reclamation plans and other information in the permit and identifies areas that will be mined during the next permit term.


