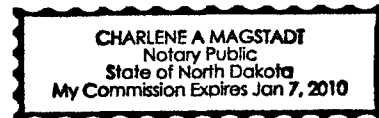

ORDER GRANTING LICENSE APPLICATION




Order
