NOTICE OF FILING AND NOTICE OF HEARING

On May 14, 2010, CPV Ashley Renewable Energy Company, LLC filed an application for a certificate of site compatibility to authorize construction of its Ashley Wind Energy Project consisting of up to 87 wind turbine generators totaling up to approximately 200.1 MW of generating capacity and associated facilities in McIntosh County, North Dakota as shown on the attached map.


A **Public Hearing** on the application is scheduled to begin on **August 23, 2010 at 11a.m. CDT in the McIntosh County Court House, 112 1st St NE, Ashley, ND 58413.** The issues to be considered are:


1. Will the location, construction, and operation of the proposed facilities produce minimal adverse effects on the environment and upon the welfare of the citizens of North Dakota?
2. Are the proposed facilities compatible with the environmental preservation and the efficient use of resources?
3. Will the proposed facility locations minimize adverse human and environmental impact while ensuring continuing system reliability and integrity and ensuring that energy needs are met and fulfilled in an orderly and timely fashion?

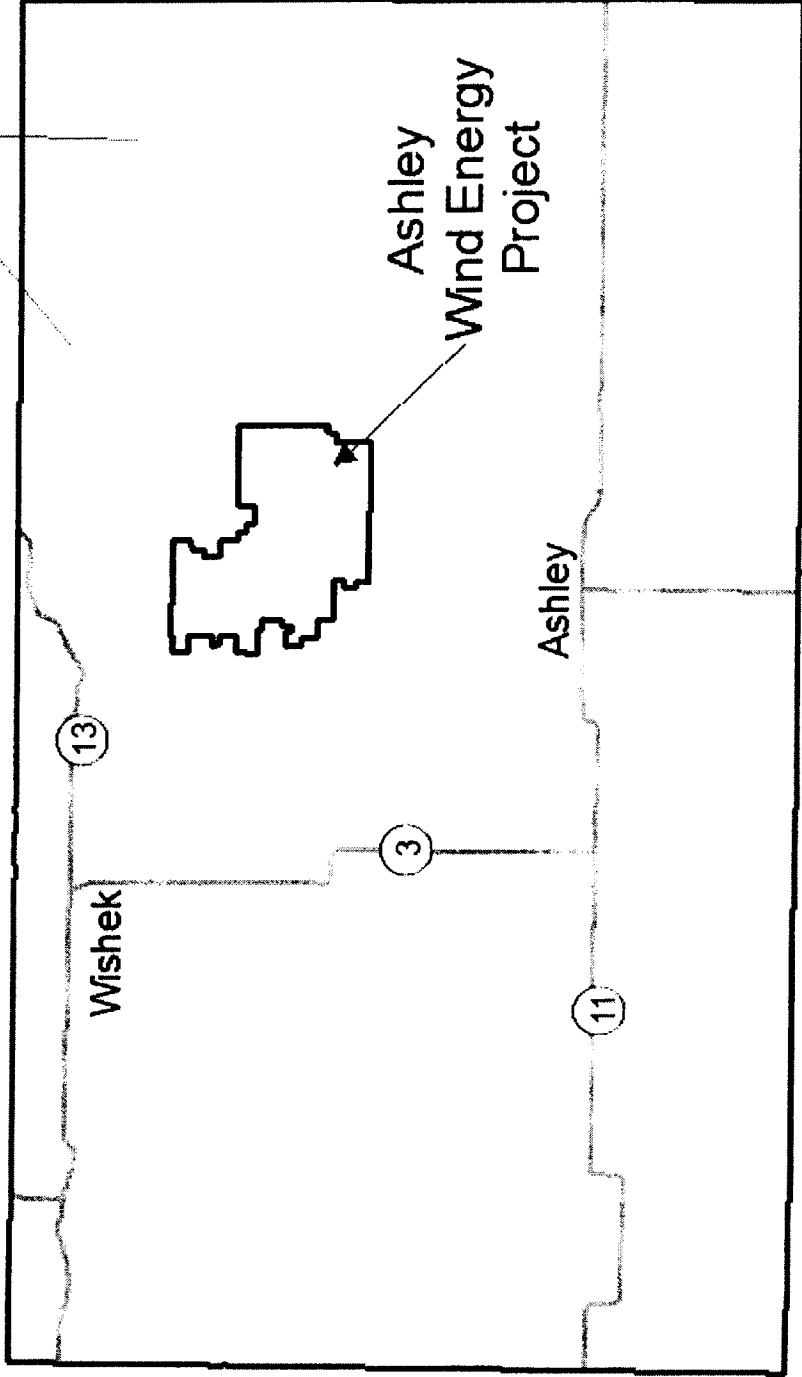
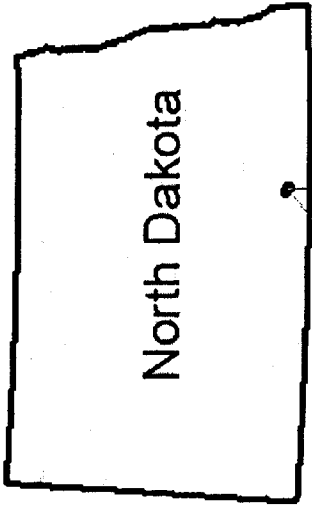
