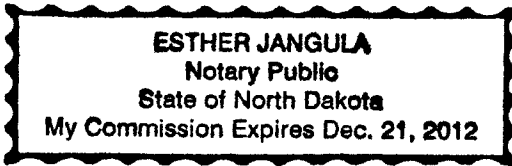

TO DISCONTINUE BUSINESS**




Order
