**ORDER REISSUING CERTIFICATES AND PERMIT  
May 20, 2009**

On October 30, 2008, in Case No. PU-08-34, the Commission issued Certificate of Site Compatibility No. 9 to M-Power, LLC (M-Power) authorizing construction of Phase II of its proposed Luverne Wind Farm consisting of 33 turbines and associated facilities totaling 49.5 MW of nameplate generating capacity in Steele County, North Dakota.

Also on October 30, 2008, in Case No. PU-08-107, the Commission issued Certificate of Corridor Compatibility No. 106 and Route Permit No. 116 to M-Power authorizing construction of approximately 13 miles of 230 kV transmission line and associated facilities in Barnes and Steele County, North Dakota.

On December 3, 2008, in Case No. PU-08-766 the Commission issued Certificate of Public Convenience and Necessity No. 5385 to Otter Tail Corporation d/b/a Otter Tail Power Company (Otter Tail) authorizing it to construct and own Phase II of the Luverne wind farm and associated 230 kV transmission facilities.

On February 20, 2009, Otter Tail and M-Power filed a joint Application for transfer of Certificate of Site Compatibility No. 9 (Case No. PU-09-73), and for transfer of Certificate of Corridor Compatibility No. 106 and Route Permit No. 116 (Case No. PU-09-136) to Otter Tail.

On April 13, 2009, the Commission issued a Notice of Opportunity for Hearing, which provided until May 12, 2009 for receiving written comments or requests for hearing. No response was received. The notice stated that the issues to be considered in these matters are whether Otter Tail agrees and is able to comply with the terms and conditions of the certificates and permits issued to M-Power and whether the requested transfers are compatible with the public interest.

Otter Tail is a Minnesota corporation authorized to do business in North Dakota as a foreign corporation, and is doing business in North Dakota as a public utility subject to the jurisdiction of and regulation by this Commission.

Otter Tail currently serves retail electric customers in eastern North Dakota, western Minnesota and northeastern South Dakota. Otter Tail is an experienced electric generation, transmission and distribution utility with the experience and resources to own and operate Phase II of the Luverne Wind Farm and associated transmission facilities.

The Commission finds Otter Tail agrees and is able to comply with the terms and conditions of the siting certificates and route permit currently issued to M-Power.


The Commission finds the requested certificate transfers compatible with the public interest.

First Reissued Certificate of Site Compatibility No. 9, First Reissued Certificate of Corridor Compatibility No. 106 and First Reissued Route Permit No. 116 are issued to Otter Tail Corporation for the 49.5 MW Phase II portion of the Luverne Wind Farm and associated 230 kV transmission facilities for which the Commission issued Certificate of Public Convenience and Necessity No. 5385 in Case No. PU-08-776.


