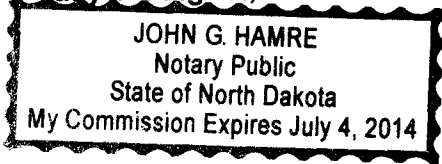

July 29, 2009


Dakota Quality Grain Cooperative, Parshall, North Dakota, operates a licensed public grain warehouse at Palermo, North Dakota, under license number 841 issued by the Public Service Commission under the provisions of NDCC Chapter 60-02. The Commission received a request to discontinue business for this facility.

Order


The Commission orders:

1. Warehouse license number 841 issued to Dakota Quality Grain Cooperative is cancelled effective immediately and Dakota Quality Grain Cooperative shall remit license number 841 to the Commission; and
2. Business at Palermo, North Dakota, is discontinued effective immediately and Dakota Quality Grain Cooperative shall not conduct any further business under license number 841.
