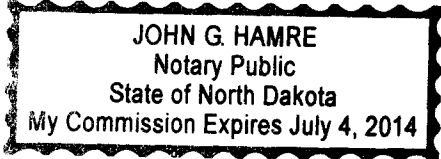


Order
