

**ANNUAL REPORT TO THE NORTH DAKOTA PUBLIC SERVICE COMMISSION  
ESSENTIAL TELECOMMUNICATIONS CARRIER CERTIFICATION  
FOR THE ABSARAKA COOPERATIVE TELEPHONE CO., INC.**

The undersigned, on behalf of the telecommunications company named below (the Company), does hereby state and certify, as follows:

1. The Company will provide service on a timely basis to requesting customers within the Company's designated service area where the Company's network already passes the potential customer's premises, and  
The Company will provide service, within a reasonable period of time, if the potential customer is within the Company's designated service area but outside the Company's existing network coverage, and if service can be provided at a reasonable cost.  
The Company is able to remain functional in emergency situations and has a reasonable amount of back-up power to ensure functionality without an external power source, and is capable of managing traffic spikes resulting from emergency situations.  
The Company is satisfying and will satisfy applicable consumer protection and service quality standards.  
The Company acknowledges that the North Dakota Public Service Commission (the Commission) may require it to provide equal access to long distance carriers in the event that no other eligible telecommunications carrier is providing equal access within the proposed designated service area.
6. The Company has met and will meet the requirements of eligible telecommunications carrier advertising.

1. A description of the amount of high-cost universal service support received by the Company in the prior calendar year and a description of how that support was used for the provision, maintenance, or upgrading of the Company's facilities and services. 
