

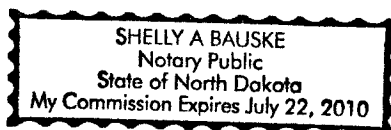

**COMPLAINT**

The North Dakota Public Service Commission staff (Staff), for its complaint against Riley Brothers Construction, alleges and shows the following:

I

Riley Brothers Construction, Incorporated (Riley Brothers) is a Minnesota based company with principle offices at 46369 208<sup>th</sup> Street, P.O. Box 535, Morris, Minnesota 56267.

II

Nustar Pipeline Operating Partnership, L.P. (Nustar) is a Kansas based company with principle offices at 7340 West 21<sup>st</sup> Street North, Suite 200, Wichita, Kansas 67205.

III

On 4 May 2009, Alan Moch, Director of the North Dakota Public Service Commission Testing and Safety Division, received an electronic mail complaint from Donna Patrick-Ward, One Call Coordinator, Nustar (Exhibit PSC Staff A). The complaint alleged a violation of the North Dakota One Call Law by Riley Brothers, under

contract with the North Dakota Department of Transportation. The electronic mail included documentation detailing Nustar's account of the incident, which occurred above Nustar's refined product pipeline in West Fargo, North Dakota. The electronic mail complaint also included copies of Nustar's subsequent contact with Riley Brothers.

#### IV

As alleged by Nustar, on 28 April 2009, Jeff Pfeifer, Nustar locator, was driving past the 9<sup>th</sup> Street overpass construction project in West Fargo, North Dakota, and discovered that a Riley Brothers employee was performing an excavation above the Nustar pipeline.

#### V

As alleged by Nustar, Mr. Pfeifer asked the Riley Brothers employee if the Riley Brothers employee was aware of a One Call ticket generated for the work that was being performed.

#### VI

As alleged by Nustar, the Riley Brothers employee stated that he was not aware of any One Call ticket.

#### VII

As alleged by Nustar, Mr. Pfeifer asked the Riley Brothers employee to stop excavating at that location and then Mr. Pfeifer proceeded to locate the pipeline with his locator.

#### VIII

As alleged by Nustar, Mr. Pfeifer inquired about the Riley Brothers employee's knowledge of the need for a One Call ticket.

## IX

As alleged by Nustar, the Riley Brothers employee stated that he was aware of where Nustar's pipeline was located, but indicated that it might be a good idea to call a locate request into the One Call Center and update a ticket that was generated in 2008.

## X

As alleged by Nustar, Mr. Pfeifer informed the Riley Brothers employee that the North Dakota One Call Law requires an updated ticket and that a locate request should have been called into the North Dakota One Call Hotline.

## XI

As alleged by Nustar, Mr. Pfeifer informed the Riley Brothers employee that his actions placed Riley Brothers personnel, the general public and the environment at risk.

## XII

On 19 August 2009, Alan Moch contacted Donna Patrick, One Call Coordinator, Nustar, by electronic mail and asked Ms. Patrick to re-submit Nustar's complaint consistent with the Public Service Commission's Third Party Damage Prevention Plan and Procedure, which was adopted after Nustar first filed its electronic mail complaint. Mr. Moch received a completed Third Party Damage Complaint form from Ms. Patrick on 21 August 2009, as required by the Commission's Third Party Damage Prevention Plan and Procedure.

## XIII

On 27 August 2009, Alan Moch contacted Chad Olson, Director of Education and Public Relations and North Dakota One Call Board Liaison, by phone about the Nustar

complaint and asked Mr. Olson to forward copies of all pertinent One Call Locate Tickets generated on the 9<sup>th</sup> Street overpass project in West Fargo, North Dakota.

#### XIV

On 3 September 2009, Alan Moch received an email with electronic copies of One Call Locate tickets from Mr. Olson which Mr. Olson had received from the North Dakota One Call vendor, James Holzer of One Call Concepts, Inc. The locate tickets show a succession of tickets and updates of the locate requests for the 9<sup>th</sup> Street project from 14 July 2008 until 23 October 2008. The last requested ticket, number 9010220 shows an update requested on 28 April 2009 with a work to begin date of 30 April 2009.

#### XV

After Jeff Pfeifer, Nustar locator, was driving past the 9<sup>th</sup> Street overpass construction project in West Fargo, North Dakota and had questioned the Riley Brothers employee about excavating without a One Call Ticket, the 28 April 2009 ticket was updated by ticket number 9014259 on 6 May 2009. (Copies of the locate tickets are attached as Exhibit PSC Staff B and a summary of the locate tickets and updates is attached as Exhibit PSC Staff C.)

#### XVI

North Dakota Century Code § 49-23-04 states:

Except in an emergency, an excavator shall contact the notification center and provide an excavation or location notice at least forty-eight hours before beginning any excavation, excluding Saturdays, Sundays, and holidays, unless otherwise agreed to between the excavator and operator. If an operator determines more time is necessary for location, the operator may request a twenty-four-hour extension of the excavation or location

notice by notifying the notification center. The notification center shall notify the excavator of the extension. An excavation begins the first time excavation occurs in an area that was not previously identified by the excavator in an excavation notice.

## XVII

Riley Brothers Construction, Incorporated, violated North Dakota Century Code Chapter 49-23 by failing to contact the One Call Hotline notification center and provide an excavation or location notice at least forty-eight hours before beginning its excavation on 28 April 2009.

## XVIII

The North Dakota Public Service Commission Damage Prevention Plan states:

### **D PROPOSED CIVIL PENALTIES:**

1. The following criteria must be used by Commission staff to determine if a civil penalty should be proposed when filing a formal complaint:
  - a. The nature, circumstances and severity of the complaint;
  - b. The degree of suspected fault on the part of the respondent;
  - c. The respondent's history of prior violations or complaints;
  - d. The respondent's ability to pay;
  - e. Any good faith effort by the respondent in attempting to achieve compliance; and
  - f. The effect the penalty may have on the respondent's ability to continue in business.

## XIX

North Dakota Century Code § 49-07-01.1 states:

Any person who violates any statute, commission order, or commission rule which applies to matters within the authority of the commission under chapters 8-08, 8-09, 8-10, 24-09, 32-25, and 51-05.1, titles 60 and 64, and title 49 except for chapter 49-22, shall, in addition to any other penalty provided, be subject to a civil penalty of not to exceed five thousand dollars. The civil penalty may be compromised by the commission. The

---

amount of the penalty when finally determined or agreed upon in compromise, if not paid, may be recovered in a civil action in the courts of this state.

XX

Using the above criteria and the Nustar Complaint, it appears that no actual damaged to the pipe occurred. However, soil above the pipe had been disturbed by Riley Brothers without obtaining a locate ticket. Had contact been made with the underground pipe, the consequences could have resulted in immediate or long term damage to the pipe, which could have resulted in an explosion, fire, injury and/or death.

XXI

It appears from the NuStar Complaint that Riley Brothers had knowledge of the requirement to call before digging, as evidenced by the previous history of locate tickets for this construction site, and the observations of the NuStar employee.

XXII

The Commission does not have on record any history of previous violations or complaints for this excavator.

XXIII

It appears from the NuStar Complaint that Riley Brothers exhibited some good faith effort to achieve compliance when the excavator ceased operations until the pipe could be properly located and subsequently requested a locate ticket, as observed by the Nustar employee and the 6 May 2009 updated locate ticket .

XXIV

North Dakota Century Code section 28-32-21(e) requires that an answer to this

complaint must be served upon the Commission within twenty days after service of the complaint, or the Commission may deem the complaint to be admitted. If Riley Brothers fails to answer within twenty days after service of the complaint, the Commission may deem the Complaint admitted. Answers must be served in the manner allowed for service under the North Dakota Rules of Civil Procedure.

### **Prayer for Relief**

Wherefore, Public Service Commission Staff seeks the following relief:

1. That the Commission find Riley Brothers in violation of North Dakota Century Code Chapter 49-23 for failing to comply with the One Call procedures outlined in North Dakota Century Code § 49-23-04.
2. That the Commission impose a civil penalty in the amount of \$1,000.00.
3. Such other relief that the Commission finds just and proper.
