ADDITIONAL INFORMATION FOR TELECOMMUNICATIONS FILING

I. Description of Service Affected:

Eliminate the Qwest Connection Guide Program. This residential-only marketing program allowed the Company to work with realtors, mortgage and moving company representatives and other move-related professionals to market Qwest services to residential customers in the process of establishing new service or moving their existing service to a new address. Customers who subscribed to a Qwest service(s) received a \$25.00 gift card that could be used for various purchases including other Qwest services. The Qwest Connections Guide was only used briefly in Arizona in 2005; consequently, there are no North Dakota move professionals or residential customers impacted by this program elimination.

II. Value/Benefit:

Qwest no longer uses the Qwest Connections Guide Program. Leaving the program in the Price Schedule when it is no longer available may cause unnecessary questions and confusion.

III. Proposed Effective Date of Change:

Qwest proposes to make this change effective October 12, 2009.
