
Dear Mr. Emineth:

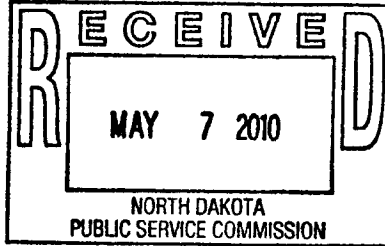
