A. My name is James R. Alders and my business address is 414 Nicollet Mall, Minneapolis, Minnesota 55401.

13 **Q. WHAT IS THE PURPOSE OF YOUR TESTIMONY IN THIS PROCEEDING?**

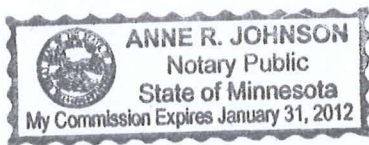
14 A. I am sponsoring the April 29, 2011 Compliance Filing, the Cost Allocation
