NOTICE OF HEARING September 20, 2011

On October 5, 2009, Northern States Power Company (Xcel Energy) and Otter Tail Power Company (Otter Tail) each filed an application for advance determination of prudence for each applicant's respective participation and ownership in the following three high voltage transmission line projects:

- A 250-mile long, 345 kV transmission line between Fargo, North Dakota and the north-west quadrant of the Twin Cities in Minnesota (the Fargo Project).
- A 200-mile long, 345 kV transmission line between eastern South Dakota and the southeast Quadrant of the Twin Cities in Minnesota (the Brookings Project).
- A 68-mile long, 230 kV transmission line between Bemidji, Minnesota and Grand Rapids, Minnesota (the Bemidji Project).

On October 6, 2011, the Commission granted a conditional advance determination of prudence for Otter Tail's investment in and construction of the Fargo, Brookings and Bemidji Projects and granted advance determination of prudence for Xcel Energy's investment in and construction of the Fargo, Brookings, Bemidji, and La Crosse Projects.

On April 29, 2011, Applicants made a compliance filing with the Commission relevant to the Brookings Project cost allocation issues and also provided evidence supporting the continued prudence of the Brookings Project.

The Commission will hold a consolidated public hearing for consideration of the Settlement Agreement on Continued Prudence beginning October 26, 2011 at 1:30 p.m. CDT in the Commission Hearing Room at the State Capitol in Bismarck, North Dakota.
