He can surpass Knight's record when the Rams play at Bradley-Beacom College in Philadelphia.

Smith said Meyer will remain on staff at Northern State helping promote the northern South Dakota school. A national search for a new head men's basketball coach is to begin immediately.

Meyer, a native of Wayne, Neb., coached at Hamline University and Lipscomb University before taking the Northern State job in 1999. Before becoming a head coach he was an assistant at Western State and at Utah.

Meyer plans to address the crowd from center court following Northern State's final regular season game on Saturday night against Southwest Minnesota State.

Conn handles another top 10 team

HARTFORD, Conn. — Kemba Walker scored 21 points for Connecticut, which got its third win this season over a top 10 team as it defeated No. 8 West Virginia 73-62 Monday.

Stanley Robinson had 15 points and 13 rebounds for the Huskies in a 77-61 win over Virginia Tech. Robinson was straight to keep its NCAA tournament hopes alive.

Kevin Ebanks had 17 points and 10 rebounds for West Virginia (21-10-5), which finished the game without coach Bob Huggins, who received two technical fouls in the final minute.

Conn hit 30 of 42 free throws and Walker was 14 of 17 from the line. West Virginia was 12 of 23 from the three-point line and hit just four of 18 point attempts.

Walker's steal and dunk made it 62-47 and Huggins received two technical fouls after calling a timeout. Walker hit three of four free throws to seal it.

Jayhawks clinch share of Big 12 title

LAWRENCE, Kan. — Xavier Henry scored 18 of his 23 points in the first half and No. 1 Kansas clinched at least a share of its sixth straight Big 12 regular season title with an 81-68 victory over Oklahoma on Monday night.

The Jayhawks (27-1, 13-0) overwhelmed Oklahoma (13-14, 4-9) from the start, building a 17-point lead in the first half and shooting 51 percent overall to extend the Sooners' losing streak in Lawrence to 10 games.

Sherron Collins added 17 points and joined fellow senior Brady Morningstar for their 124th win together, most all-time in Kansas history.

The Jayhawks have won 13 straight games for their best start since opening 34-1 in 1996-97 and have the nation's longest home winning streak at 58 games.
