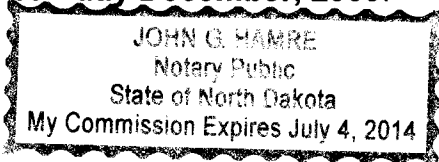

**ORDER REVOKING AUCTION CLERK LICENSE**




Bob or Winona Penfield dba Penfield Auctions, Bowman, North Dakota holds auction clerk license number 586 issued by the Public Service Commission under the provisions of NDCC Chapter 51-05.1.

On September 25, 2009, the Commission was notified that the bond issued to Bob or Winona Penfield dba Penfield Auctions would be cancelled effective November 29, 2009. NDCC Chapter 51-05.1 requires that auction clerks maintain adequate bond coverage and provides that the Commission, without hearing, shall revoke the license effective the date the bond is cancelled unless a new bond is filed or notice to reinstate the cancelled bond is received. No bond or reinstatement was filed and auction clerk license number 586 issued to Bob or Winona Penfield dba Penfield Auctions is revoked.

**Order**

The Commission orders that auction clerk license number 586 issued to Bob or Winona Penfield dba Penfield Auctions is revoked as of November 29, 2009. Bob or Winona Penfield dba Penfield Auctions can no longer clerk at public auction under auction clerk license number 586 and auction clerk license number 586 shall be surrendered to the Commission immediately.
