Over the last 12 months - Wenck is providing professional services to the PSC for post-construction siting inspections on seven sites under PO/Contract number: PSC Case # PU-10-123. To date we have not billed PSC for these services, but have accrued (work in progress effort of) approximately \$6,100 dollars towards the contract amount of approximately \$29,250. Note that contract PU-10-123 was not signed until November of 2010 and most of the work related to the post-construction effort could not be initiated until Spring of 2011.
