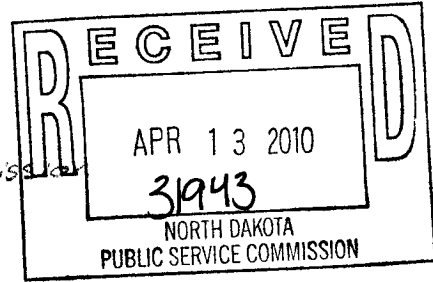

3. That the Petitioner has declared and affirmed that the representations contained in said Petition are true, correct and complete to the best of his knowledge, information and belief.
4. The Petitioner is an interested person as defined by the laws of the State of North Dakota.
5. That the decedent died on April 20, 2005, and that more than three (3) years have elapsed since the death of said decedent; and it appears from the Petition that the time for original appointment proceedings has expired.
6. That on the basis of the statements in the Petition, this Court has jurisdiction of this estate, proceedings and subject matter.
7. That the venue for this proceeding is in McLean County, North Dakota, because decedent was the owner of a mineral interest in real estate located in McLean County, North Dakota.
8. That all of the decedent's heirs are as identified in the Petition commencing this proceeding.
9. That no Will or authenticated copy of a Will of decedent probated outside of this state has been admitted to probate, or administration had in this state.
10. That the Last Will and Testament of the Decedent has not been probated within three (3) years from death and by reason thereof the assumption of intestacy is final.

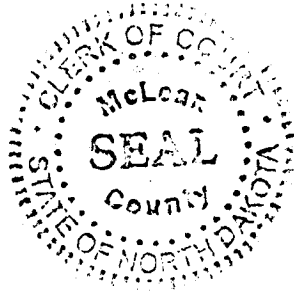
