NOTICE OF RECEIPT OF REVISION APPLICATION

BNI Coal, Ltd. has filed an application for Revision No. 30 to Surface Coal Mining Permit BNCR-9702 to add 676.48 acres to the western portion of the permit area as described as follows: the W $\frac{1}{2}$ of the NW $\frac{1}{4}$ of Section 21; the NW $\frac{1}{4}$ of the SW $\frac{1}{4}$ of Section 21; the S $\frac{1}{2}$ of Section 29; the NW $\frac{1}{4}$ of Section 32; and, the W $\frac{1}{2}$ of the NE $\frac{1}{4}$ of Section 32, all in T142N, R84W of Oliver County. The revision application updates the environmental resource information and the mining and reclamation plans for the acreage being added to Permit BNCR-9702.

You may submit written comments or objections on the proposed permit revision application and its effects on the environment and on surface owners of the land in the permit area. You may request an informal conference with the Commission and the applicant on the revision application. The reasons for requesting an informal conference must be stated in the request. Written comments, objections, or requests for an informal conference must be made by August 23, 2010

If there is an informal conference, you may request a formal administrative hearing on the Commission ruling on the application. Your request for a formal hearing must be made within thirty days of the Commission ruling on the application.
