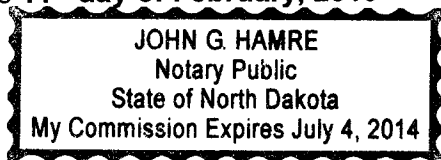

February 10, 2010




