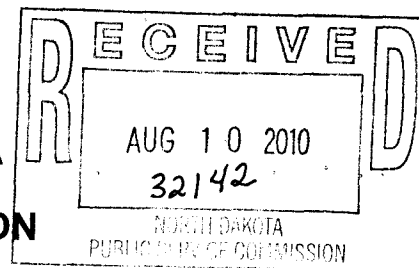

NOTICE OF RECEIPT OF REVISION APPLICATION

July 28, 2010

On March 10, 2010, Basin Cooperative Services applied for Revision 36 to Surface Coal Mining Permit BCGH-8204 for the Glenharold Mine located near Stanton, North Dakota. Revision 36 proposes to change the post-mining land use on 325 acres in Section 31, T144N, R84W, Mercer County from an agricultural to industrial land use to expand the Leland Olds Station (LOS) special waste disposal site. This revision also updates the surface and mineral ownership information, permanent pond hydrology and makes minor changes to the standards and methods for measuring revegetation success in response to a midterm review of the permit by the Reclamation Division.

You may submit written comments or objections on the proposed permit revision application and its effects on the environment and on surface owners of the land in the affected area. You may request an informal conference with the Commission and the applicant on the revision application. The reasons for requesting an informal conference must be stated in the request. Written comments, objections, or requests for an informal conference must be made by **September 17, 2010**.

If there is an informal conference, you may request a formal administrative hearing with the Commission ruling on the application. Your request for a formal hearing must be made within thirty days of the Commission's ruling on the application.



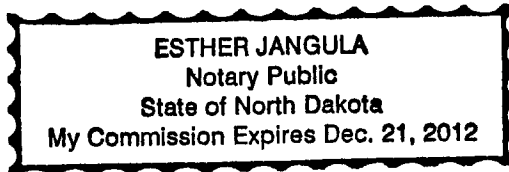
