NOTICE OF RECEIPT OF RENEWAL AND REVISION APPLICATIONS

May 12, 2010

BNI Coal, Ltd. has applied to renew Surface Coal Mining Permit BNCR-9702 and update legal, financial, and operation plans to continue surface coal mining and reclamation operations in the existing permit area located in:

All or portions of Sections 3, 4, 5, 6, 7, 8, 9, and 10, T141N, R84W; and Sections 21, 27, 28, 31, 32, 33, and 34, T142N, R84W, all in Oliver County, containing 6,342.05 acres.

The five-year permit renewal will allow BNI to continue mining and reclamation operations in Permit No. BNCR-9702 until August 2, 2015. Revision No. 32 identifies areas that will be mined during the next permit term and updates the legal and financial section, mining and reclamation plans and other information in this permit.


You may submit written comments or objections on the proposed permit renewal and revision applications and their effects on the environment and on surface owners of the land in the permit area. You may request an informal conference with the Commission and the applicant on the renewal and revision applications. The reasons for requesting an informal conference must be stated in the request. Written comments, objections, or requests for informal conference must be made by June 28, 2010.

If there is an informal conference, you may request a formal administrative hearing on the Commission ruling on the applications. Your request for a formal hearing must be made within thirty days of the Commission ruling on the applications.
