Dear Mr. Nitschke:

On March 8, 2018, an informal hearing was held regarding decommissioning filings submitted in the above-referenced matter. At the informal hearing, the Commission requested that NextEra Energy Resources, LLC subsequently file information regarding the difference of the per turbine decommissioning cost estimate for turbines in Case No. PU-10-102 as compared to the decommissioning cost estimates for other projects. This information was subsequently filed as Informal Hearing Late-Filed Exhibit 4 in the above-referenced matter.

As detailed in Late-Filed Exhibit 4, upon further evaluation, DEMCO believes it is appropriate to use the decommissioning value of \$125,000.00 per turbine for the Wilton I Energy Center. Late-Filed Exhibit 4 contains a revised decommissioning cost estimate to account for this revision. As a result, FPL Energy Burleigh County Wind, LLC proposes to increase the amount of financial assurance placed for the facility to account for the slight increase in the total decommissioning costs now estimated for the facility.



FIRST AMENDMENT TO GUARANTY

This FIRST AMENDMENT TO GUARANTY (this "First Amendment") is made and entered into as of this 23 day of April, 2018 by NEXTERA ENERGY CAPITAL HOLDINGS, INC. ("Guarantor") for the benefit of NORTH DAKOTA PUBLIC SERVICE COMMISSION (the "Counterparty").

Recitals

A. Guarantor made and issued that certain Guaranty dated as of December 19, 2017, for the benefit of Counterparty (the "Underlying Guaranty").

B. FPL ENERGY BURLEIGH COUNTY WIND, LLC is an indirect subsidiary of Guarantor, and Guarantor will derive benefit from amending the Underlying Guaranty as provided by this First Amendment.

Agreement

NOW, THEREFORE, in consideration of the benefits recited above, the sufficiency of which the Guarantor acknowledges, Guarantor hereby agrees as follows:

- 1. The dollar limitation of "Three Million Nine Hundred Sixty Thousand U.S. Dollars (U.S. \$3,960,000)" set forth in Section 1(a) is hereby deleted and the dollar limitation of "Four Million One Hundred Twenty-Five Thousand U.S. Dollars (\$4,125,000)" is inserted in lieu thereof.
2. Guarantor hereby ratifies the Underlying Guaranty as amended by this First Amendment, and declares the same to be in full force and effect.
3. This document may be executed in any number of counterparts, each of which will be deemed an original and all of which together will constitute one and the same instrument.
