In Case No. PU-10-210, Hess Corporation ("Hess") submitted a \$100,000 filing fee for the Tioga Gas Plant Expansion Project ("Project") which was received by the Public Service Commission ("Commission") on July 1, 2010. The Project is not yet fully completed.

In Case No. PU-13-728, Hess Corporation and Hess Tioga Gas Plant, LLC ("Hess TGP") filed a joint application to transfer the Certificate of Site Compatibility for Energy Conversion Facility (Certificate No. 18) issued in Case No. PU-10-210 from Hess to Hess TGP. Hess understands that funds remain from the \$100,000 filing fee submitted in Case No. PU-10-210 and that those funds will continue to be used and drawn upon by the Commission to monitor and inspect the Project through its completion.

It is the preference and request of Hess Corporation that the filing fee submitted in Case No. PU-10-210 remain with the Commission under Hess Corporation's name upon approval by the Commission of the Application to transfer Certificate No. 18 to Hess TGP. Hess Corporation hereby consents to the Commission's use of the filing fee funds to monitor and inspect the project through completion by Hess TGP. Hess Corporation requests that upon completion of the Project any remaining filing fee funds be refunded to Hess Corporation.
