
On June 23, 2010, North Dakota Oilseed Mills, LLC submitted a partial application for a grain warehouse license to operate a canola processing facility at Northwood, North Dakota. North Dakota Oilseed Mills, LLC submitted a letter with the application, asking the Commission to determine the bond amount they will be required to file.


A **public hearing** on the application is scheduled for **August 31, 2010 at 1:00 p.m.** in the **Commission Room, Grand Forks County Office Building, 151 South 4th Street - 6th floor, Grand Forks, North Dakota.** The issues to be considered are:

1. Whether North Dakota Oilseed Mills, LLC should be issued a grain warehouse license.
2. Whether North Dakota Oilseed Mills, LLC, if issued a grain warehouse license, should be required to file a surety bond in excess of \$50,000, the amount as determined based on the total physical capacity of the warehouse facility.
3. Whether North Dakota Oilseed Mills, LLC, if issued a grain warehouse license, should be subject to monitoring of grain warehouse activities for whatever period of time is deemed necessary.
