Otter Tail Power Company ("Otter Tail") hereby submits its 2010 Resource Plan Filing. Enclosed please find fifteen (15) copies of the filing and a Certificate of Service. Also enclosed is the original document as an unbound single-sided copy of the filing pursuant to the DPS/PUC letter dated May 28, 1996 requesting such copies.

Three pages of "Appendix B" and all of "Appendix F" contain confidential business information that is considered proprietary. These sections have been marked with the caption "Non-Public Information" to indicate "Trade Secret Information" according to Minn. Stat. Sec. 13.37, subd. 1(b). This statute protects certain "government data" as that term is defined at Minn. Stat. Sec. 13.02, subd. 7, from being disclosed by an administrative agency to the public. The information being supplied is considered to be a "compilation" of data that, (1) was supplied by Otter Tail, (2) is the subject of reasonable efforts by Otter Tail to maintain its secrecy, and (3) derives independent economic value, actual or potential, from not being general known to or accessible to the public.

Six of the 15 copies provided to the Commission contain the trade secret data and are marked "Non Public Information". The Office of Energy Security and Office of the Attorney General have received Non Public copies. Public copies or electronic versions have been distributed to all other persons on the attached service lists. The Public version will also be posted on the Company's website at www.otpc.com.
