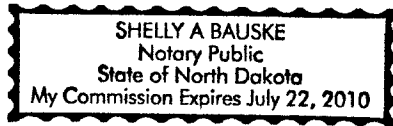


Submitted with the application was a statement by Corey Theede that the customer desires electric service to be provided by the applicant. Service is to be provided at a point located in:

Richland County, North Dakota.**


Otter Tail Power Company has made a prima facie showing that it should serve the customer.


