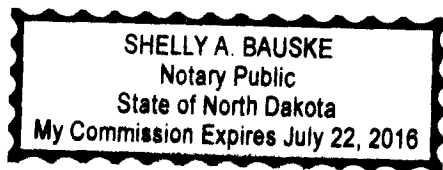

Submitted with the application was a statement by Continental Resources that the customer desires electric service to be provided by the applicant. Service is to be provided at a point located in:


**The NE ¼ of Section 15, Twp 159 N, R 95 W, Williams County,
