PLEASE TAKE NOTICE that on March 16, 2011, the NORTHEAST JUDICIAL DISTRICT executed an Order that was duly filed in the above proceeding on March 18, 2011, appointing the Public Service Commission to act as trustee of a trust fund to be established and administered in accordance with North Dakota Century Code Chapter 60-04, joining Grabanski Grain LLC and Platte River Insurance Company as parties, and setting a hearing on the portion of the Commission's motion asking that Platte River Insurance Company be required to deposit the bond proceeds with the Commission.
