Thank you for your assistance in making the Grabanski Grain, LLC records available for our inspectors to review.

The following are the grain records that we have not found, but are needed in order to continue our evaluation to determine the amount and validity of the filed claims.

1. Complete settlement information for the grain received on Grabanski Grain, LLC scale tickets from Louie Slominksi, Jr., Merlyn Grabanski, and anyone else that may have delivered corn between September and early November in 2010. This information should include proof of payment or redelivery to the producers. The information should also include whether any drying charges were assessed against the producers. If any drying charges were owed to Grabanski Grain, LLC, please provide proof that the drying charges were paid and to whom the drying charges were paid.
2. Did Grabanski Grain, LLC apply discounts for quality issues such as heat damage, mold damage, frost damage, test weight, or any other factors? Please provide us with the discount schedules used by Grabanski Grain, LLC between November 2007 and November 2010.
