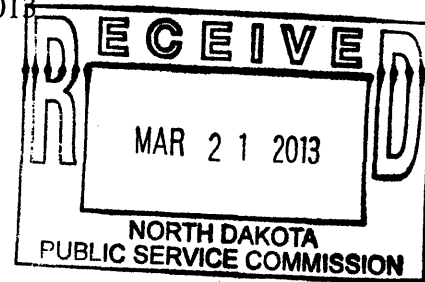

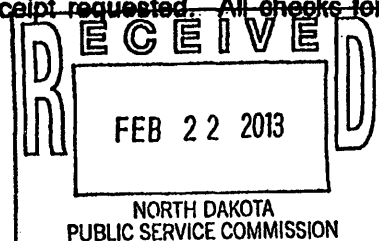




claims, expenses, and return of excess proceeds have been delivered as evidenced by the certified mail return receipts which are on file with the Public Service Commission.

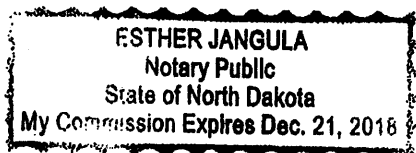


