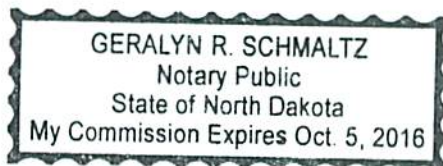

**NOTICE OF FILINGS, NOTICE OF INFORMAL HEARING,
AND NOTICE OF OPPORTUNITY FOR HEARING**

August 1, 2012

The North Dakota Public Service Commission's (Commission) November 2, 2011 Order issued to Hiland Operating, LLC (Hiland) a Certificate designating a corridor and a Permit designating a route for the construction of a 14.1 mile, 6-inch pipeline and associated facilities in McKenzie County, North Dakota, for the transmission of natural gas liquids (Project).

The Commission's June 27, 2012 Findings of Fact, Conclusions of Law and Order granted amendments to Hiland for corridor and route modifications and issued First Amended Certificate of Corridor Compatibility No. 125 and First Amended Route Permit No. 134.

On July 26, 2012, Hiland filed a request for a modification to the First Amended Certificate of Corridor Compatibility No. 125 and the First Amended Route Permit No. 134 allowing Hiland to increase the size of the Project from a 6-inch diameter pipe to a 8-inch diameter pipe. Hiland also filed an application for waivers of procedures and time schedules. The Project is shown on the attached map.

In its application for waivers of procedures and time schedules, Hiland requests that the Commission waive the following:

- Procedures that require separate filings of applications for a certificate of corridor compatibility and a route permit,
- Procedures that require separate notices of such applications,
- Procedures that require separate hearings on such applications,
- Procedures that require a public hearing on an application for a certificate of corridor compatibility,
- Procedures that require a public hearing on an application for a route permit.

The issues to be considered in Hiland's application for waiver of procedures and time schedules are:

1. Are the proposed facilities of such length, design, location, or purpose that they will produce minimal adverse effects and that adherence to applicable procedures and time schedules may be waived?

2. Is it appropriate for the Commission to waive any procedures and time schedules as requested in the application?

The issues to be considered in Hiland's applications for amended certificate of corridor compatibility and amended route permit are:

1. Will the location, construction, and operation of the proposed facilities produce minimal adverse effects on the environment and upon the welfare of the citizens of North Dakota?
2. Are the proposed facilities compatible with the environmental preservation and the efficient use of resources?
3. Will the proposed facility locations minimize adverse human and environmental impact while ensuring continuing system reliability and integrity and ensuring that energy needs are met and fulfilled in an orderly and timely fashion?

Those interested are invited to comment on the applications in writing. Persons desiring a hearing must file a written request identifying their interest in the proceeding and the reasons for requesting a hearing. **Comments and requests for hearing must be received by August 31, 2012.** If deemed appropriate, the Commission can determine the matter without a hearing.

An **Informal Hearing** of this matter is scheduled to begin on **August 29, 2012**, at **1:30 p.m. CDT** in the Commission Hearing Room on the 12th floor of the State Capitol. At the informal hearing, the Commission will discuss this matter with the parties and interested members of the public.

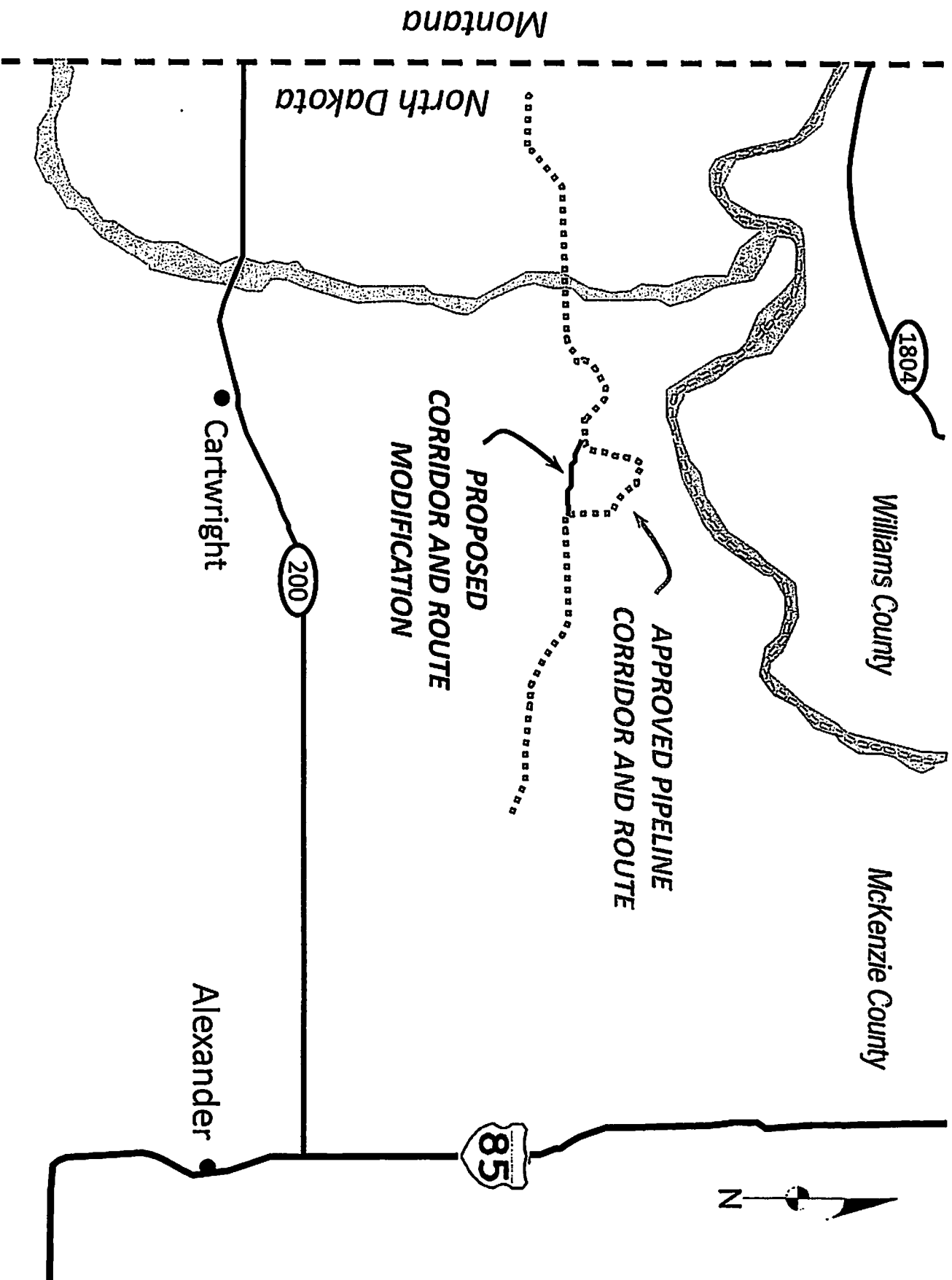
