



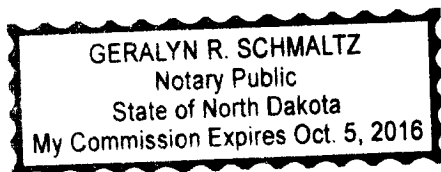

The Falkirk Mining Company has filed a revision application to Surface Mining Permit NAFK-9503 to update all introductory, legal, financial, compliance, environmental, operations, and reclamation plans to reflect the addition of approximately 16,924 acres to the existing permit. The land being added to the permit is located in:


You may submit written comments or objections on the proposed permit revision application and its effects on the environment and on surface owners of the land in the permit area. You may request an informal conference with the Commission and the applicant on the revision application. The reasons for requesting an informal conference must be stated in the request. Written comments, objections, or requests for informal conference must be made by February 7, 2011.

If there is an informal conference, you may request a formal administrative hearing on the Commission ruling on the application. Your request for a formal hearing must be made within thirty days of the Commission ruling on the application.




