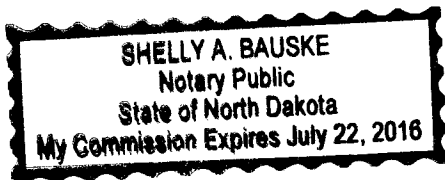





The NW ¼ of the SE ¼ of Section 15, Twp 130 N, R 50 W, Richland County, North Dakota.


