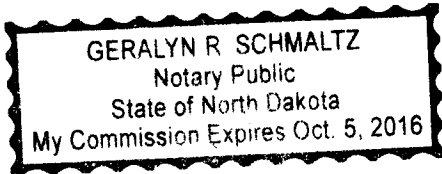





The SE ¼ of the SW ¼ of Section 30, Twp 129 N, R 55 W, Sargent County, North Dakota.


