The Reclamation Division has reviewed The Coteau Properties Company's October 14th e-mail that addresses the remedial measures that were taken to abate Notice of Violation (NOV) 1004. In addition, a follow-up field inspection of the site was conducted on October 20, 2010. The Reclamation Division considers Coteau's actions adequate in addressing the remediation measures required by NOV-1004. With completion of the remedial actions, we are terminating NOV-1004 and the termination notice is enclosed.

The Reclamation Division identified a typographical error while reviewing NOV-1004 when preparing the termination notice. Notice of Violation 1004, dated October 4, 2010, incorrectly stated the permit number as **NACT-8103**. Please be advised the correct permit number for which the violation was issued is **NACT-8102**.
