
The City of Granville, North Dakota respectfully requests an extension of the deadline to respond to the Commission's Order on Probable Violations until July 12, 2011. The deadline is presently set for June 6, 2011.

The Granville City Council meets on the first Monday each month. The City Council's June 2011 meeting will be held at 7:00 PM June 6, 2011 – the same date as the deadline to respond to the Commission's Order on Probable Violations. Because responses to certain portions of the Commission's Order on Probable Violations will require official action of the City Council, additional time will be required. An extension of the deadline until July 12, 2011 – one day after the City Council's July 2011 meeting will permit the City Council to take the official action(s) necessary to respond to the Commission's Order.

In the interim, the City submits the attached Pipeline Pressure Test Report pursuant to Item 2 of the Commission's Order on Probable Violations.
