We have changed the name of Bear Paw Energy, L.L.C., a subsidiary of ONEOK Partners, L.P., to **ONEOK Rockies Midstream, L.L.C.** to tie more closely our natural gas gathering and processing operations in the Rockies to the ONEOK Partners name. Bear Paw Energy has been a part of ONEOK since 2004 when ONEOK became majority interest owner of Northern Border Partners. Northern Border Partners was renamed ONEOK Partners in May of 2006.

Going forward, you will see the Bear Paw Energy assets referred to as ONEOK Partners to increase recognition of the ONEOK Partners name in the Williston Basin and Powder River Basin areas. Company name recognition is important in attracting employees for our expanding operations.

The ONEOK Rockies Midstream name will be used on contracts, pipeline markers and on facility signage.

Additionally, the name change supports our internal Becoming ONE initiative.
