EPND has made the appropriate text revisions and submits a "Revised Page 46" to correct this matter. For the convenience of this Commission and its Staff, a redlined and clean version of Page 46 is enclosed to replace the originally filed page.
3	Updated Table 6 - Field Delineated Wetlands Crossed by the BPP US Route and supplemental information to Section B.4.b(8)(i) Route , to EPND's Application for a Route Permit	EPND is supplementing Section B.4.b(8)(i) Route , of its <i>Application for a Route Permit</i> , based on results of McCain's Addendum report for minor reroutes and additional workspaces areas including the additional workspace near the proposed Kenaston Station site. This supplemental filing includes an "Updated Table 6 - Field Delineated Wetlands Crossed by the BPP US Route" and supplemental information to update Section B.4.b(8)(i) of its Route Permit application.
