**RE: Revision 21, Renewal #3 Completeness Review Responses for Permit NAFK-9503**

Dear Mr. Deutsch:

Falkirk submits the following responses to the completeness review items from your December 21, 2010 letter required to be addressed before the revision can be deemed complete.

**Section 1.5.1 - Permit Area Surface and Coal Interests**

- 1. Please provide documentation that the surface lease for Tract 3 has been or will be extended beyond the March 31, 2013 expiration term to at least the end of the new permit term. Also, please ensure that the documentation is a certified copy since the copy of the lease currently in the permit does not indicate that it has been recorded at the county courthouse. NDCC 38-14.1-14(1)(k). (SAS)***

The lands covered by the surface lease for Tract 3 are owned by Great River Energy (GRE) and contain facilities required by The Falkirk Mining Company (Falkirk) for its surface coal mining operations. Falkirk will extend the surface lease prior to its March 31, 2013 expiration date. The parties to the surface lease elected not to record the lease. The Corporate Secretary of Falkirk provided a certificate stating that the lease submitted in the permit is a complete and genuine copy of the original.

- 2. The copies of coal lease numbers 03332 and 03323 are not certified. Please provide certified copies. NDCC 38-14.1-14(1)(k). (SAS)***
