The purposes of the prehearing conference are to consider and determine a procedure for the use of telephonic testimony for the consolidated hearing of these cases; to determine a procedure for the marking, identification, and offer of exhibits; to determine whether the consolidated hearing should be structured so as to differentiate among the several cases for the offer of evidence; and to consider and determine any other matters necessary or desirable to facilitate and expedite the conduct of and procedure for the consolidated hearing.
