

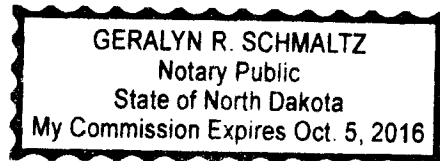
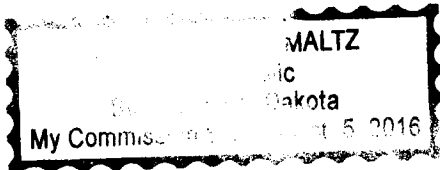

Section 15, Twp 156N, R 92W, Mountrail County, North Dakota.




