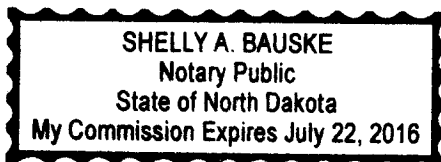

The North Dakota Public Service Commission (Commission) alleges as follows:

**1.**

Mitchell Feeds, Inc., a Minnesota business corporation authorized to do business in North Dakota, operates as a roving grain buyer in North Dakota and is licensed under North Dakota Century Code Chapter 60-02.1.

**2.**

Mitchell Feeds, Inc., PO Box 9112, Fargo, North Dakota 58106, operates as a roving grain buyer in North Dakota under license number 3159.

**3.**

A surety bond is on file with the Commission as required by North Dakota Century Code § 60-02.1-08. The surety bond is for \$70,000 and identified as number

15352088 with Western Surety Company, 101 South Phillips Avenue, Sioux Falls, South Dakota 57104-6703, as surety.

**4.**

On February 1, 2011, James and Cynthia Burckhard of Towner, North Dakota, filed a letter for collection of outstanding funds owed to them for grain sold to Mitchell Feeds, Inc. Subsequently, David Steeves of Sherwood, North Dakota, Gene W. Allen, attorney representing David Deslauriers of Sherwood, North Dakota, Paul A. Rohde of Halliday, North Dakota, Don Ackerson of Sherwood, North Dakota, Steven Neameyer of Mylo, North Dakota, Lana Anderson/Northland Farms of Sherwood, North Dakota, Greg Busch/Busch Farms, Inc. of Crosby, North Dakota, and Mitch Preskey of Glenburn, North Dakota, each filed letters for collection of outstanding funds owed to them for grain sold to Mitchell Feeds, Inc. Copies of the letters are attached as Exhibit A.

**5.**

The Commission was informed and believes that there are outstanding obligations for unpaid claims for grain sold to Mitchell Feeds, Inc. as a roving grain buyer under North Dakota Century Code Chapter 60-02.1 for which bond protection is available under the provisions of North Dakota Century Code § 60-02.1-08 and for any credit-sale contracts for which protection is available from the credit-sale contract indemnity fund under North Dakota Century Code §§ 60-10-04 and 60-10-05.

**6.**

Mitchell Feeds, Inc. is insolvent under North Dakota Century Code Chapter 60-02.1, in that it is unable upon proper demand to make payment for grain purchased or marketed or make redelivery for grain delivered.

7.

The Commission is legally entitled to be appointed trustee of the trust fund provided under North Dakota Century Code Chapter 60-02.1.

8.

Bond proceeds will be needed to redeem outstanding receipts issued by Mitchell Feeds, Inc. North Dakota Century Code § 60-02.1-31 provides:

Each surety on the insolvent licensee's bonds must be joined as a party to the insolvency proceedings. If it is in the best interests of the receipt holders, the court may order a surety to deposit some or all of the penal sum of the bond into the trustee's trust account pending determination of the surety's liability under the bond.

9.

If there are any credit-sale contract claims, proceeds from the credit-sale contract indemnity fund may be needed to meet the licensee's obligations to any holders of credit-sale contracts. North Dakota Century Code § 60-10-05 provides:


Upon the insolvency of a licensed warehouse or a grain buyer and a declaration that the Public Service Commission serve as the trustee, the Public Service Commission shall make the proceeds of the credit-sale contract indemnity fund available for use in meeting the licensee's obligations with respect to the reimbursement of any person who sold grain to the licensee under a credit-sale contract and who was not fully compensated in accordance with the contract.

**WHEREFORE** the Public Service Commission respectfully requests:

1. That the Court declare Mitchell Feeds, Inc. **INSOLVENT** within the meaning of North Dakota Century Code Chapter 60-02.1 and establish the date of insolvency as February 1, 2011, the date that the first claim for collection of outstanding funds owed for grain sold was filed.
2. That the Court **APPOINT** the Public Service Commission as trustee of the trust fund under North Dakota Century Code § 60-02.1-29.

3. That the Court **JOIN** Western Surety Company, 101 South Phillips Avenue, Sioux Falls, South Dakota 57104-6703, as surety on the bond for Mitchell Feeds, Inc. as a respondent in this action.

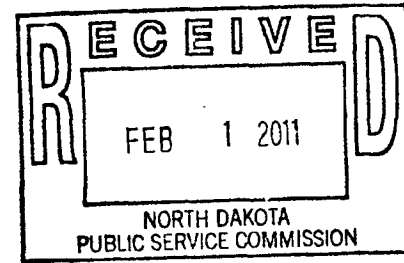

I have enclosed information regarding this matter and hope you can help us to find resolve.

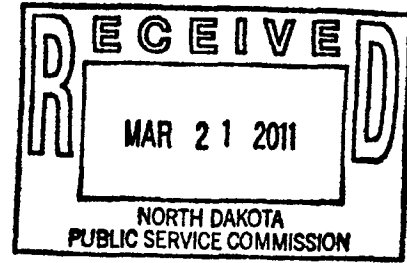

In going over the current PSC website we now see that they have claimed insolvency so where does that leave us at this point?

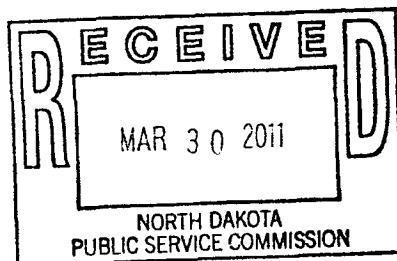
We see they were bonded but how will that help us? Can we file a claim against them to get our money?

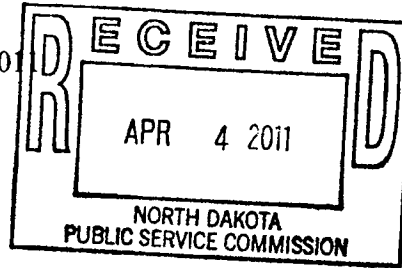

Dear Ms. Richter:

Thank you for taking time to speak with me this afternoon regarding this matter.

McGee, Hankla, Backes & Dobrovoly, P.C., represents David Deslauriers, who delivered Nusun Sunflowers to Mitchell Feeds, Inc., pursuant to the above-referenced contract dated April 5, 2008, (the "Agreement") a copy of which is included as Attachment A. As of this date, the unpaid balance on sunflowers Mr. Deslauriers delivered to Mitchell Feeds, Inc., is **\$157,346.99**, of which \$150,272.99 is for sunflowers and \$7,074.00 is for freight Mitchell Feeds, Inc., agreed to pay. We understand there is a \$70,000 surety bond for this roving grain dealer and that it may be possible for the North Dakota Public Service Commission to eventually take possession of other assets of Mitchell Feeds, Inc., and/or its affiliates or principals. We hereby request the assistance of the PSC in collecting amounts due and owing Mr. Deslauriers.

In addition to the unpaid balance noted above, Deslauriers suffered an additional \$27,048.00 in damages when he sold the remaining production at a price below that which Mitchell Feeds, Inc., was obligated to buy. If this component of damages is within the scope of the PSC's authority to assist in collection, we hereby include these damages, which would bring the total of Mr. Deslauriers' claim to \$184,394.99. Details of the damage calculation are discussed in the attached letter to Mitchell Feeds, Inc., and outlined in Attachment B.

Also included as Attachment C are copies of scale tickets and associated documents for each of the fourteen loads sold between January 29, 2009 and August 20, 2009. Mr. Deslauriers received payment in full for the first two loads, partial payment for four loads, and no payment for eight loads.

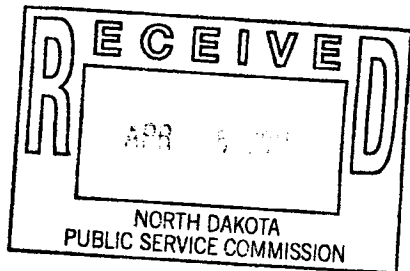

I have tried to contact Bob Mitchell by telephone concerning this matter but he hasn't returned any calls.

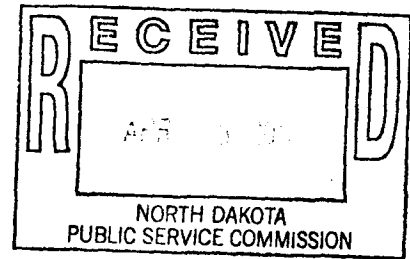

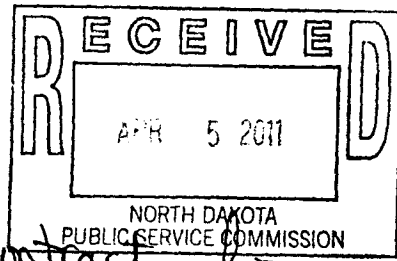


Gentlemen:

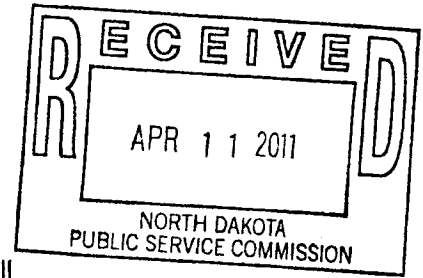

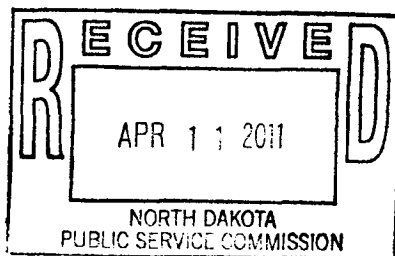

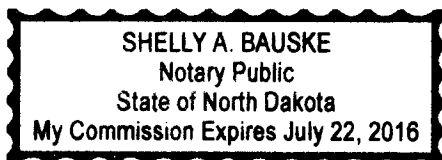

The North Dakota Public Service Commission (Commission) has jurisdiction over roving grain buyers under North Dakota Century Code Chapter 60-02.1, which provides for the appointment of the Commission as trustee of the assets of a roving grain buyer upon the filing of a notice with the Commission that the roving grain buyer has defaulted in the payment for grain purchased by the buyer.

On February 1, 2011, James and Cynthia Burckhard of Towner, North Dakota, filed a letter for collection of outstanding funds owed to them for grain sold to Mitchell Feeds, Inc. Subsequently David Steeves of Sherwood, North Dakota, Gene W. Allen, attorney representing David Deslauriers of Sherwood, North Dakota, Paul A. Rohde of Halliday, North Dakota, Don Ackerson of Sherwood, North Dakota, Steven Neameyer of Mylo, North Dakota, Lana Anderson/Northland Farms of Sherwood, North Dakota, Greg Busch/Busch Farms, Inc. of Crosby, North Dakota, and Mitch Preskey of Glenburn,

North Dakota, each filed letters for collection of outstanding funds owed to them for grain sold to Mitchell Feeds, Inc. Mitchell Feeds, Inc. is unable, upon proper demand, to pay for grain purchased or make redelivery for grain delivered.

The Commission is informed and has reason to believe that there are outstanding obligations for unpaid claims for grain sold to Mitchell Feeds, Inc. as a roving grain buyer under North Dakota Century Code Chapter 60-02.1 for which bond protection is available under the provisions of North Dakota Century Code § 60-02.1-08 and for any credit-sale contracts for which protection is available from the credit-sale contract indemnity fund under North Dakota Century Code §§ 60-10-04 and 60-10-05.

It is in the best interest of all claimants that the Court declare Mitchell Feeds, Inc. insolvent and establish the date of insolvency as February 1, 2011, the date the first claim for collection of outstanding funds owed for grain sold was filed, and that the Commission be appointed Trustee, and be given the powers under North Dakota Century Code Chapter 60-02.1 so that all claimants will be treated fairly.


It is also in the best interest of all claimants that the surety be joined as a party as provided for under North Dakota Century Code § 60-02.1-31.

Upon the insolvency, the Commission has the authority under North Dakota Century Code § 60-10-05 to make payment to any person who sold grain to the licensee under a credit-sale contract and who was not fully compensated under the contract.

The Court has jurisdiction under North Dakota Century Code § 60-02.1-29, which provides for the filing of this action in the District Court, South Central Judicial District.
