The purpose of the prehearing conference is to consider and decide matters necessary or desirable to facilitate and expedite the hearing on these administrative matters scheduled to be heard beginning on August 9, 2011, to provide a just, speedy, and inexpensive disposition of these matters. The conference attendees will primarily discuss with the hearing officer consolidation of applications, and, specifically, what consolidation means for these matters, as well as discovery, issues, witnesses, documentary evidence, anticipated motions, pre-filed

testimony, and other preliminary matters, as necessary. Opportunity will be given counsel and other participants to discuss any of the problems confronting them.


The prehearing conference will be digitally recorded, and will be conducted in an informal manner.


