Mr. Combs,

Bear Paw Energy, LLC (BPE), a subsidiary of ONEOK Partners, LP, Tulsa, Oklahoma, has proposed the Garden Creek NGL Pipeline Project. This project will entail the construction of approximately 55 miles of 12-inch diameter pipeline in McKenzie County, North Dakota and approximately 10 miles of pipeline in Richland County, Montana this pipeline will be designed to transport natural gas liquids (NGL) to various delivery points along the route. This project is currently scheduled to begin construction in July 2011 and will require a minimum of 90 days to complete construction with restoration to immediately follow. The planned pipeline corridor is shown on the attached map.

Pipeline construction activities will typically occupy a 100-foot right of way. Following construction, the pipeline will occupy a 50-foot permanent right of way. To minimize impacts portions of the proposed route will be collocated with existing utility corridors.

Please provide comments regarding the presence of State Mineral Trust Lands located within a one mile of the proposed Project corridor. E3 will utilize this information in the preparation of a Public Service Commission application for the project. E3 has been retained by APL to provide environmental consulting support for this project. Please contact myself by phone or email if additional information is required.

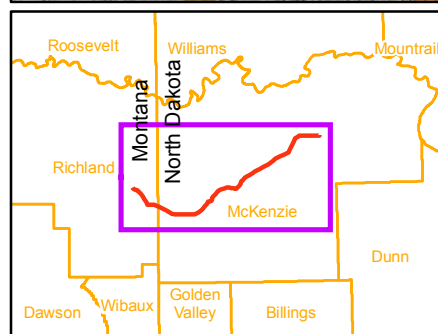
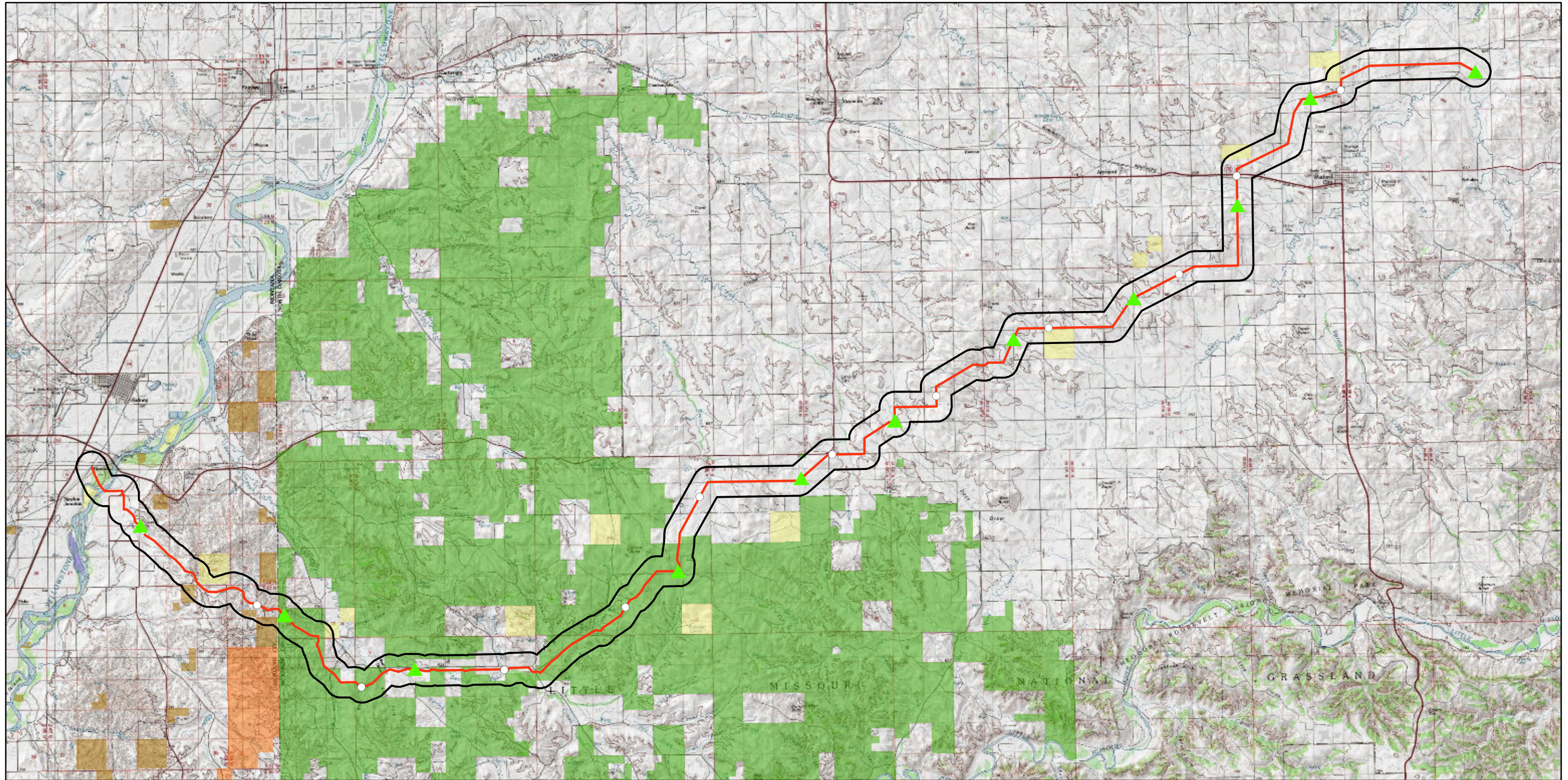

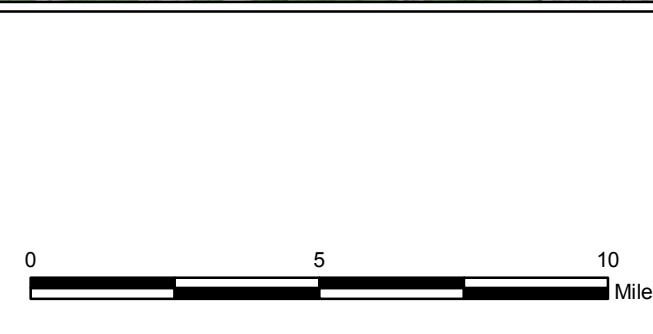
