<b>2.0</b>	<b>Findings of Fact, Conclusions of Law and Order</b> All accompanying items in Item 2.0 are items that were pointed out by Mr. Fahn to clarify and identify areas that were testified about during the public hearing in Watford City, ND. While not all items were highlighted, meeting attendees are expected to follow these findings during construction. Only questions and discussions are listed in the minutes.	
2.1	Paragraph 22 of the findings: Bear Paw will use a 95 to 100 foot construction right of way and have a permanent 50 foot right of way.	
2.2	Paragraph 11 of the findings: Who is the certified archeologists that will be monitoring the sites? Bill McCarthy stated that this person will be under contract but has not been hired at this point.
