Sealed bids will be received by the Board of City Commissioners until 5:00 pm, June 6, 2011, for "Water Main Replacement District No 18-10". Bids will be opened and publicly read in the City Commissioner's room in the City Offices, 423 6th St, Devils Lake, ND, 5:30 pm, June 6, 2011.

Scope of work includes replacement of approximately 3000 LF of 4" and 6" cast iron water main, associated water service lines and connections, and fire hydrants. Work will be completed on 7th St NE between 2nd Ave and 10th Ave in Devils Lake. Approximate quantities include 3000 LF of 8" PVC; 2000 LF of 1" water service line; 2000 LF of curb/gutter removal and installation; 82 curb stops; 8 fire hydrants; and 3500 SY of asphalt removal and street repair.



TELECOMMUNICATIONS RELAY SERVICE SURCHARGE
May 18, 2011

On April 21, 1993, Governor Edward T. Schafer approved House Bill No. 1028 that established a program to provide specialized telecommunications services and equipment to the communications impaired. The relay services program is funded by an access line surcharge paid by the customers of local exchange companies and radio communications service providers.

The relay services program is administered by the Information Technology Department of the State of North Dakota. Before June 1 of each year, the Public Service Commission calculates the amount of the surcharge based on cost data and other information provided by the Information Technology Department.

The Commission has calculated the 2011-2012 surcharge to be included in bills to customers is \$.04 per access line per month.


